### Wyre Councillor Adam Leigh's Report

Lane Ends Amenity Area, waiting for the council to liaise with colleagues. The landowners are Environment Agency and pay Wyre to do some of the maintenance on the site, will contact the Environment Agency as I will need to involve them to transfer the maintenance to Pilling Parish Council. Councillors were informed a vehicle accessed the marsh from the top car park and flattened the fence. The Environment Agency is looking to replace the fence.

Wyre Council is conscience dog patrols in rural areas have decreased, Cllr. Vincent is pursuing this and would appreciate any problems in rural areas. Planning application for Glenfield Caravan Park is to be considered by the Planning Committee.



### Lancashire County Councillor Matthew Salter

The Councillor reported on standing water at Eagland Hill, United Utilities have investigated and confirmed no issues with sewers or septic tanks and Lancashire County Council will fill the depression. Lancashire warm spaces grant scheme is open for applicants.
