4701. APOLOGIES FOR ABSENCE

Apologies were received from Cllr. E. Moorat. Wyre Council Holden also apologised for this meeting. It was noted that Cllr. Mrs. B. Schofield has missed over six meetings, which creates a vacancy, but under the Local Elections (Parish and Communities) Rules 1986, SI 1986/2215, r8(3) as the period has less than six months to ordinary elections the Parish Council is not bound to so. The present Councillors' term of office will cease in May, 2019. Resolved: The Parish Council will not be looking to fill the vacancy.

4702. NOTIFICATION OF INTERESTS

Councillors were asked to declare interests in the matters to be discussed and reminded that changes to their Register of Interests must be made within 28 days.

Cllr. P. M°Whirter and Cllr. G. Curwen declared an interest as members of the Community Hall Committee

4703. MINUTES OF THE LAST MEETING

Resolved: The minutes of the meeting held on 14th November, 2018 having been circulated, were agreed and signed by the Chairman as a true record.

4704. PUBLIC PARTICIPATION

Standing Orders were suspended to allow persons present to speak.

Lancashire County Councillor Salter

Cllr. Salter has spoken to Paul Bond from the Environment Agency he is interested in attending the Water meetings in Pilling. Cllr. N. Cookson and Cllr. J. Barton will be attending the Wyre Flood Forum and Mark O'Donnell, County, will attend. It was raised that the Environment Agency were not maintaining Pilling Water and new lifting gear has been installed on the outward sea wall doors.

Standing Orders were reintroduced and the meeting resumed.

4605. PILLING IN BLOOM

Councillors discussed the work schedule for entering Pilling in Bloom in North West in Bloom for 2019. Cllr. R. Whiteside reported that Stan Raby is happy to take on the job volunteering to attend Wyre and work in the village with Cllr. Mrs. E. Cookson drawing up the portfolio.

4606. POSSIBLE BUS SHELTER ON TAYLORS LANE

Whilst the majority of replies are positive, there are concerns with the location as it is almost opposite an industrial estate, which has recently applied to increase the number of units and so increase traffic exiting the site. Other queries were raised including using a different style of shelter, but the Parish Council needs to re-locate the one removed from the Elletsons Arms. Alternative locations were suggested including Lancaster Road and North West industrial Estate, but these are on private land.

Resolved: To present to Lancashire County Council for their considerations in the New Year.

4607. MEMORIAL TO MARK THE END OF WWI

Councillors wished to mark the end of WWI with a lasting tribute and suggestion so f flower tubs and seats were made, also a small version of the soldier on the Village Hall field and prices will be sought.

Resolved: To return next month with possible designs and costs.

4608. EAGLAND HILL ANPR

The Grantscape submission included electrical work, the firm who quoted is unable to fulfil the work and another contractor has been secured, but the work involved is more extensive than originally quoted for. The Wi-Fi signal needs more support and a data cable to improve connections, this results in an increase of £500. As Grantscape funding has been granted; it cannot be increased. The Parish Council discussed making up the shortfall.

Resolved: The Parish Council will make up the shortfall in the Grantscape funding in light of the additional work required.
