## 4580. APOLOGIES FOR ABSENCE

Apologies were received from Cllr. N. Cookson and Cllr. E. Moorat.

## **4581. NOTIFICATION OF INTERESTS**

Councillors were asked to declare interests in the matters to be discussed and reminded that changes to their Register of Interests must be made within 28 days.

## 4582. MINUTES OF THE LAST MEETING

Resolved: The minutes of the meeting held on 10<sup>th</sup> January, 2018 having been circulated, were agreed and signed by the Chairman as a true record.

## 4583. PUBLIC PARTICIPATION

The meeting was suspended to allow residents to speak.

Visit from John Blundell concerning the setting up of a Pilling Flood Action Group John Blundell is responsible for the depots in Fleetwood, out of hours officers and Emergency Officer. Wyre has plans in place for emergencies including the Wyre Flood Plan. It states how Wyre Council responds to and recovery plans in the event of flooding with 14 Flood Risk Summaries for areas in Wyre. He sits on the Wyre Flood Forum, held quarterly and Making Room for Water where agencies attend. He is looking to develop local Flood Action Groups to be active in their local area in times of flooding. Flooding problems are investigated by officers who report back to the Flood Groups to build in community resilience. Each household should have an Emergency Plan and vulnerable people and/or properties should be known to the group for assistance. Wyre Councillor Holden volunteered to chair the Pilling Flood Action Group with residents to work with agencies to address local problems arrange site meetings and find solutions. The Chairman added that during the floods in November emergency contact numbers were non-existent, there was no help for Pilling. Action Groups are provided with emergency numbers / mobiles to contact. Cllr. Curwen reported that Pilling Parish Council regularly meets with the Environment Agency, Natural England, NFU and the MP and have progressed with Pilling's problems albeit frustratingly slowly.

John Blundell said that an Action Group needs to be Proactive – locating local problems and responsive – working on what to do and also to distribute sandbags to vulnerable persons; Wyre Council will provide sandbags to communities. The next Wyre Flood Forum is 9<sup>th</sup> March and the Flood Action Group will be welcome. Local flooding problems need listing and sending to John Blundell next week for inclusion at the Flood Forum.

## Wyre Councillor G. Holden

Cllr. Holden referred to a current planning application which he has called in for the planning committee to consider rather than delegated decision.

The meeting was resumed.

## Chairman's Report

Cllr. J. Savage reported on a thank you card received from a grateful resident and a donation towards next year's party.

## Report of the representative on the Pilling Memorial Hall Committee/Pilling 20:20

Cllr. P. McWhirter reported the committee were looking for architects and are considering 5 at present, interviews will take place to determine what they can do and offer for the site. This is funded by an advance of £40,000 from the Big Lottery as part of the half million grant. The Committee are visiting local Village Halls to learn from their mistakes and note their successes. The challenge continues as to build the hall to serve Pilling will take more than the Lottery grant.

#### **Senior Citizens' Christmas Party**

Cllr. Mrs. E. Cookson reported that everything went well on the night and the entertainment has been booked for this year. The lack of numbers was discussed with a suggestion of individual invitations to those residents who are eligible, also to offer lifts on the night.

#### School Lane site meeting

Following a reply from County Cllr. Keith Iddon, cabinet member for Highways and Transport, he will meet with Councillors, but no date specified yet.

## **Eagland Hill ANPR**

Cllr. Mrs. D. Schofield reported on the successful planning permission for the pole at Copthorne Farm and the funding submission to Grantscape's Eagland Hill Windturbine fund. The first ANPR camera is working and has information signs attached.

## **Halite Community Panel**

Cllr. Mrs. D. Schofield reported that at the last meeting Halite spoke to calm fears about what's going to happen with the development. There are fears concerning the land based caverns that are collapsing, but Halite are creating new caverns under the River Wyre as extra storage is needed now that the North Sea gas field is running out.

## Water Group Meeting – 2<sup>nd</sup> February

Cllr. G. Curwen reported that local farmers are working with the NFU to apply for a license to dig out the seaward channel beyond the sea wall. The NFU has submitted the application to the Environment Agency after ensuring that Natural England is happy with it. If granted this will give a 10 year license to clean out the channel. The license on the Cocker has caused environmental damage and the Environment Agency is looking to run both river licences together. The license will need payment and this will hopefully come from the local farmers affected who will also carry out the work. This should drop water levels by at least 1 metre. It was stressed to the MP that crops are being ruined and there is no protection for farmers who are growing the food the country depends on. Contractors were on site last Friday, but didn't find any problems with the outfall; the Environment Agency is to use divers. The Chairman has been contacted by the Environment Agency as to size and type of pumps for use over the sea wall.

## 4591. QUESTIONS FOR COUNCILLORS

## Road Resurfacing:

**Garstang Road** from Ambleside to Crawley Cross Farm from 5<sup>th</sup> to 23<sup>rd</sup> March for carriageway resurfacing works. Dates differ from the information boards on the road side. **Lancaster Road, Out Rawcliffe** from Bradshaw Lane to Rawcliffe Road from 9<sup>th</sup> to 13<sup>th</sup> April to allow pre-surface dressing patching.

## **Bone Hill Lane**

A Lancashire County Council engineer; acknowledges Bone Hill Lane is adopted and has reported the potholes; unfortunately the web site doesn't so nothing can be reported. Will direct this to the new County Councillor.

#### Numbering on Smallwood Hey Road

The Parish Council has written back to Daniel Sutton suggesting that the scheme would be more acceptable if BOTH a name and number could be used. Waiting for reply.

## Parish Lengthsman working in Catterall

The Chairman of Catterall Parish Council wishes to thank Pilling Parish Council for allowing their lengthsman to help out in Catterall during the sickness of their Parish Lengthsman.
