# 5413. APOLOGIES FOR ABSENCE

Apologies were received from Wyre Councillor Adam Leigh.

#### **5414 DECLARATIONS OF INTERESTS**

Councillors declared interests on agenda matters and reminded that any change in interests must be notified to the clerk within 28 days.

Cllr. G. Curwen, Cllr. P. McWhirter and Cllr. J. Savage declared their interests as members of Pilling Village Hall Committee. Cllr. Mrs. J. Judkins declared an interest as a member of Pilling Community Action.

## **5415 MINUTES OF THE PREVIOUS MEETINGS**

Resolved: The minutes of the meeting held on 13<sup>th</sup> March 2024 having been circulated, were agreed and signed by the Chairman as a true record.

### **5416 PUBLIC PARTICIPATION**

Resolved: Standing Orders were suspended to allow residents to speak.

#### Wyre Councillor Adam Leigh

The Councillor sent a report - Planning application at Glenfield Caravan Park for the siting of 43 caravans and attenuation pond has been permitted. The enforcement case at Crossings Cottage, Lambs Lane went to appeal against the enforcement notice, and this was dismissed. Orders have been given to demolish the building to ground level. Speed checks have been authorised for Taylor's Lane and will be carried out in due course. Further checks have been requested for Garstang Road as there are speeding issues during the day at school times and at night.

Residents are frustrated with Wheel Lane flooding as the planned works from Lancashire County Council hasn't come to fruition. Although they state works have been completed,

the dyke is still blocked, and the road is still flooded. I have been in touch with County to challenge their claim that work has been undertaken and am awaiting a reply from the highways district lead. I believe United Utilities are due to attend on Friday to install a valve on a 4-inch main pipe. I have also asked Cllr Salter to chase this up again with County. Problems with Create Homes are ongoing.

Councillors noted it was refreshing to receive a comprehensive report from our Wyre Councillor. There was great concern with the Glenfield decision with creeping growth impinging on St. John's Church and possible flooding impacts with the dyke running through the site. Councillors wish to understand and discuss planning decision with the planning officer.

Resolved: The Parish Council meeting and Standing Orders were resumed.

#### 5417 CLERK'S REPORT

Resolved: The defibrillator re-location on Garstang Road is now complete, thanks to our residents, and Grantscape has approved claim.

#### **5418 PARISH COUNCIL POLICIES**

Resolved: Councillors reviewed and accepted Complaints Procedure and Code of Conduct.

Resolved: Councillors accepted the Social Media Protocol, written by the Communications Committee; it enables the Parish Council to interact in a way that improves the communications both within the Council and between the Council and people, businesses and agencies it works with and serves.
