#### 4364. ELECTION OF CHAIRMAN

Resolved; Cllr. J. Savage was elected as Chairman of Pilling Parish Council for one year.

#### 4366. APOLOGIES FOR ABSENCE

Apologies were received Cllr. Mrs. E. Cookson, Cllr. J. Savage, Cllr. Mrs. B. Schofield and Cllr. W. Whiteside. Wyre Councillor G. Holden also sent apologies. In the absence of the Chairman Vice-Chairman E. Moorat presided over the meeting.

#### **Including a Police Report**

**March, Crimes** An offender under the influence of unknown substances was arrested when he smashed windows to enter a bedroom at a property in Pilling, he resisted arrest and bit a police officer, he is a 25 year old man from Blackpool and was sentenced to 120 days in prison.



Sexually explicit photos were sent unlawfully to a mobile phone belonging to a female under the age of 16 years.

Anti-social behaviour in March saw a resident of School Lane reporting eggs thrown at their property; also a neighbour screaming at children turned violent when confronted. A person running on Fluke Hall Lane was passed by a caravan too closely when the driver stopped, approached the runner and ripped their headphones out while shouting, the driver then followed her when the runner set off again.

**April Crimes** Unknown offenders have picked and thrown around daffodils and traffic cones in a second incident in School Lane (see ASB).

**Anti-social behaviour in April** saw daffodils picked and thrown around and cones thrown into the hedge on School Lane. A dispute over parking on Garstang Road causing verbally threatening behaviour and males were asked to leave a holiday cottage were reported for threatening to smash a window.

The meeting was resumed.

#### Pilling in Bloom

Cllr. W. Whiteside has changed the route due to needing to show a community site, so Lane Ends Amenity Area is to be included.

#### **Representative on Pilling Memorial Hall/Pilling 20:20**

Cllr. E. Moorat reported on the developments on the new field by the developers, who should be finished by 27<sup>th</sup> May, when it will be handed over to Pilling 20:20. There is still unrest concerning the 'depression' as it interferes with the potential use of the new field. The car park is to be created shortly and this will allow access to the recreation area.

#### Queens 90<sup>th</sup> Birthday Celebrations

Cllr. Mrs. E. Cookson sent an update of the procedures for the occasion in Pilling. The celebration will be organised by St. John's School and will take place on Thursday 16<sup>th</sup> June at St. John's Church Hall. Lunch boxes are to be packed at school and brought to the church to be eaten at 12.30, followed by a concert in church when the Chairman will present the Parish Council's medals. Councillors and spouses are asked to help out on the day.

#### 4377. QUESTIONS TO COUNCILLORS

#### **Pilling Memorial Hall Grass Cutting**

The Parish Council was asked to quote for cutting the grass on the play area and the HR Committee duly met to discuss this. The committee recommended £30 per visit, but the Parish Council representative on the Memorial Hall considered there should be no charge as it is a public facility. This will be discussed fully next month.

#### Grantscape Funding

The Morecambe Bay windturbines grant is open to submissions with grants of £5,000 and £75,000 available. Cllr. E. Moorat explained that the Parish Council can apply and if successful give the money to the Memorial Hall. He added that it would compromise

the Big Lottery application if they name a number of other grant funders. The Councillors supported investigating applying for funding to supply a Multi Use Games Area on the new field.

#### **Defibrillator Training**

The next training session will be held in the Golden Ball on Monday 23<sup>rd</sup> May from 7.30pm. The Parish Council is looking to produce a certificate for attendees.

## Lancashire County Council site meetings Damside

The Parish Lengthsman and Clerk meet with Lancashire County Council about the drains on Damside, which goes across the field and into the Broadfleet; it is to be jetted to hopefully clear any blockages.

#### **Back Sands Lane**

The dykes on Back Sands Lane have deteriorated until there is little depth to them now. The Parish Council will look to investigate digging out to allow water to drain off the road. Cllr. G. Curwen will visit James and Norman Kellet and make them aware of possible developments.

There being no further business the Chairman closed the meeting at 9.10pm.
