4256. APOLOGIES FOR ABSENCE

Apologies were received for this meeting from Cllr. J. Barton.

The Chairman held a minutes silence following the recent passing of Mrs. Ruby Whiteside and Mr. Walter Lawrenson.

4257. CO-OPTION TO PILLING PARISH COUNCIL

At an extraordinary Parish Council meeting three new parish councillors were co-opted. The Chairman welcomed two of the new Councillors trusting that they will enjoy their term of office representing the best interests of Pilling.

4258. NOTIFICATION OF INTERESTS

Councillors were asked to declare interests in the matters to be discussed and reminded that any changes to their Register of Interests must be made within 28 days.

4259. MINUTES OF THE LAST MEETING

Resolved: The minutes of the meeting held on 10th June, 2015 having been circulated, were agreed and signed by the Chairman as a true record.

4260. PUBLIC PARTICIPATION

The meeting was adjourned to allow the residents present to speak.

Including: Police Report

Outbuildings were broken into in Eagland Hill and Winmarleigh and farming vehicles stolen. One of which was recovered and two males are being interviewed for the theft and handling of stolen goods. The NHP team appeals to everyone to ring 101 for any suspicious activity and registration numbers would help massively.

Sergeant Freaney apologies for the lack of content in the crime and incident figures, but due to a decrease in staff and increased work load everything is stretched. A volunteer is co-ordinating the figures at present and hopefully in future a second volunteer will compile the summaries. The Councillors appreciated the appointment of a second volunteer as they were concerned about the deterioration of information available. There is great concern at the low priority given to the Policing in Over Wyre. The Parish Council will appeal to the Chief Inspector, as the Divisional Commander, to support the local policing team in rural areas.

Wyre Councillor Graham Holden

Councillors were disappointed that Cllr. Holden had not attended the meeting nor sent a report.

The meeting was resumed.

4261. VACANCIES FOR PARISH COUNCIL REPRESENTATIVES

Pilling Parish Councillors welcome the three new Councillors and nominated these Councillors to fill the vacancies of representatives to committees and outside bodies. Resolved: Councillors were elected to the following committees:

Cllr. Mrs. D. Schofield, Human Resources Committee and Wyre Area Lancashire Association of Local Councils; Cllr. N. Cookson, Finance Committee and Pilling in Bloom committee and Cllr. G. Curwen was elected to the Wyre Area Road Safety Committee

4262. PILLING COMMUNITY HALL, GRASS CUTTING

At last month's meeting the Parish Council was asked to consider taking on the grass cutting of the newly to be defined football pitch on the field. Initial concerns were raised as to extending the Parish Lengthsman's duties and the capacity of the present equipment, which needs discussing along with a possible charge. Councillors discussed the present state of the field, with the drainage taking place and were informed, by a member of 20 20, that a small football pitch is to be ploughed and reseeded. It is advisable to leave any consideration until 20 20 informs the Parish Council that the football pitch is ready and only then to consider if the Parish Council equipment can cope with the work required.

Resolved: To write to Pilling Memorial Hall Committee that the Parish Council will need to wait until the football pitch is ready and inspected as to level of work involved before considering a grounds maintenance contract.

4263. WYRE'S LOCAL PLAN

Wyre is asking Pilling Parish Council to comment on the Issues and Options during their consultation of the Local Plan. Councillors felt that this should be answered in unison with the surrounding Parish Councils and will arrange a meeting. The Chairman added that: as the planning ambassador he had attending initial consultations when Councillors asked about the definition of affordable housing and landowner's permission on proposed sites. Wyre answered that all the possible sites have been included and these will be whittled down, but there would not be compulsory purchase. The pressure on the infrastructure prompted the reply 'infrastructure provides reaction to a situation'. Pilling's lack of bungalows was raised, the aging population in Pilling has been highlighted and this may enable them to remain in the parish.

Resolved; To arrange a cluster meeting with Pilling, Stalmine, Out Rawcliffe, Winmarleigh, Nateby and Hambleton Parish Councils to discuss the Local Plan.

Planning Training

Wyre is holding planning training on Monday 13th July, with Pilling having three places, the Chairman and Vice Chairman have agreed, but another member is needed. *Resolved; ClIrs. J. Savage, E. Moorat and W. Whiteside will attend.*

4264. REVIEW THE PARISH NEWSLETTER

Councillors discussed the recent form and distribution of the Pilling newssheet against the production of the booklet with distribution by Councillors. The editor expressed concern at the lack of articles generated by Councillors which means that many issues contained similar topics: it needs to be more relevant. Councillors were again asked to submit articles including diary events from organisations in Pilling, by the end of September, for the next edition to be ready on 14th October. These will again be hand delivered by the Councillors and the delivery list will be reviewed.

Resolved: To produce the Pilling Parish Newsletter for delivery three times per year, October, February and June, by the Councillors.

4265. PARISH LENGTHSMAN TRAINING

Councillors considered sending the Parish Lengthsman on a First Aid Course. Adult education proved fruitless, but Barton Grange is running a certified course in practical first aid skills, which aims to give confidence in assisting in emergency situations at a cost of £29.50 in September, October and November.

Resolved: That the Parish Lengthsman attends a First Aid course on 10th September, at Barton Grange.

4266. BOUNDARY COMMISSION

The Boundary Commission is to commence an electoral review of Lancashire County Council; the Parish Council will wait until the proposals are posted before commenting. *Resolved: To comment on the proposals once posted.*
