4643. APOLOGIES FOR ABSENCE

Apologies were received from Cllr. E. Moorat and Mrs. B. Schofield. Lancashire County Councillor Salter and Wyre Councillor Holden also sent apologies

4644. NOTIFICATION OF INTERESTS

Councillors were asked to declare interests in the matters to be discussed and reminded that changes to their Register of Interests must be made within 28 days.

4645. MINUTES OF THE LAST MEETING

Resolved: The minutes of the meeting held on 13th June, 2018 having been circulated, were agreed and signed by the Chairman as a true record.

4646. PUBLIC PARTICIPATION

There were no members of the public present.

4647. GENERAL DATA PROTECTION REGULATIONS:

Resolved: Councillors completed their information sheets in line with the General Data Protection Regulations.

Parish Councils will have 12 months in which to enact the General Data Protection Regulations and Councillors are aware of the effect on web site in order to ensure security, which increases the monthly cost.

Resolved: To pay the increase by direct debit to cover security and encryption.

4648. PILLING MEMORIAL HALL

Following the AGM CIIr. E. Moorat proposes to apply for funding for an opening ceremony for the new hall, the event to be organised by volunteers. As a public body the Parish Council is permitted to hold grants on behalf of organisations, with the financial regulations of the council adhered to prior to paying invoices.

Resolved: The Parish Council is pleased to hold the grant and will accept invoices from the Committee treasurer in line with the Parish Council's Financial Regulations.

4649. HERITAGE POPPY TRAIL

Garstang and District Heritage Society wish to know if the Parish Council plaque for the War Memorial needs to be separate from St. John's Church or is it acceptable if they are on one plaque?

Resolved: One poppy plaque to be mounted on the gate to St. Johns Church.

4650. WITHDRAWAL OF POLICING IN RURAL WYRE

Lancashire Constabulary held meetings with officers at Garstang that their roles are going and they are to be redeployed on immediate response at Fleetwood or Lancaster, this leaves only two inexperienced PCSOs to cover the whole of rural Wyre from Bleasdale to Knott End; in effect a complete withdrawal of policing from Over Wyre, carried out without consultation or regard for communities. At present there are 5 neighbourhood officers and a sergeant in Garstang a withdrawal will cut rural policing disproportionately to urban centres. Pilling Parish Council has invested in ANPR cameras to assist the Police in their duties and are now being removed.

Cllr. W. Whiteside reported that Cllr. N. Cookson will be escorting the judges. Cllr. Mrs. E. Cookson added that the Parish Lengthsman is to water floral beds from 7am. Cllr. N. Cookson thanked residents for their help in watering.

Report of the representative on the Pilling New Community Hall Committee

Cllr. McWhirter reported on the finalised design, waiting for QA to give costings. Two further bids have been made for £50,000 to cover changing rooms and £100,000 for sports in the new hall. A site meeting was held in 3rd July with funders to show what has been achieved to date.

Water Meeting

The members met with Rachel Crompton, Lancashire County Council's Flood Risk Manager, who seemed to be impressed with the level of commitment and action carried out by Councillors and residents rather than waiting for authorities. She considered authorities should be assisting and funding some of the work in Pilling, following the successful rebuilding of the culvert at Fanny Bridge. Dykes feeding into this culvert are flowing and should take away water from Wheel Lane and Smallwood Hey Road.

Pilling Parish Council July, 2018

School Lane

Councillors met with Lancashire County Council highways to discuss the state of School Lane with the pending resurfacing. Matters raised were slippages between Thornbank and Village Farm, sewers adjacent to Pilling Pottery, Broadfleet Bridge and the junction with Fluke Hall Lane.

Garstang Road

Cllr J. Barton reported on Lancashire County Council viewing Garstang Road at the bend to the West of Calcalds Farm. There was disappointment at the state of the edgings and the 10 inch drop to the hedge. He proposed to fill in the banking and build it up, following a number of accidents.
