5307. APOLOGIES FOR ABSENCE

Apologies were received from Wyre Councillor Leigh.

5308. DECLARATIONS OF INTERESTS

Wyre Councillor Adam Leigh

The Councillor updated the Parish Council with a number of recently raised issues. Building at Stakepool is a civil rather than planning matter and a planning enforcement matter on Lambs Lane has gone to appeal. United Utilities engineers have attended water stood at New Lane, Eagland Hill confirms there is no sewage, the road has subsided allowing water to pool. Lancashire County Council will be investigating. Wyre Council is stepping up dog patrols please inform Wyre of all hot spots.

A vote against planning change making it easier to build on green belt was unanimously carried by Wyre Council. The Councillor raised concerns over crime and anti-social behaviour in Pilling and hopes to arrange a meeting with Andrew Pratt, deputy Police and Crime Commissioner.

Lancashire County Councillor Salter

The clerk added that no rural grass verges have been cut this year, normally this is a three-cut service per year, County missed in April and have still not started in Pilling. The clerk will write to County Cllr. Salter to investigate, copying in Parish Councillors.

Credit was expressed to the diligent work of Stan and Denis, who replaced all the raised beds and replanted the area.

Report of the representative on Pilling Village Hall

Cllr. P. McWhirter reported on the recent Vintage Weekend, which was very successful, despite rain on the Sunday night. This has proved to be a popular event. Thanks are extended to all the volunteers who make these events possible. Cllr. G. Curwen thanked Paul for levelling the soil at the car park.

Pilling Community Action

Cllr. Mrs. J. Judkins reported on Flag Making to be displayed at Pilling Coffee Feast. We've had three successful sessions to date with the theme of inspiration and aspiration.

Our Future Coast

It was reported Natural England has bought Sand Villa as they did with Caunce Grange at Winmarleigh. Approximately 600 acres either side of the embankment.

Lane Ends Plaque Update on progress from Cllr. Curwen. Background; This is a private agreement to erect a plaque at Lane Ends depicting the building of Pilling Embankment. Environment Agency has agreed to the location. The Parish Council agreed, in principle, to provide a mount for the plaque provided by the family. The initial agreement involved Parish Council labour by the Parish Lengthsman, unfortunately timing forced Stan unable to continue due to pressure of Parish Council work. As a result, Cllr. S. Phillpotts volunteered to take on the project, he met with Cllr. G. Curwen and Alan Brown on site to discuss progress. Cllr. S. Phillpotts agreed to take a key role in facilitating the erection at Lane Ends.

5316. ITEMS RAISED BY COUNCILLORS

Cllr. S. Irvine raised the claxon on the Golden Ball, it is believed to warn residents of impending floods and was erected in the 1940's. Cllr. S. Irvine will approach the owner and Cllr. P. McWhirter to raise with Pilling Village Hall Committee.
