Wyre Councillor Holden

A verbal report was received; fly-tipping on Fluke Hall Lane was reported to Wyre Council, who were unable to act as it was on private land. Sheep have been noticed on land next to Head Dyke Lane, there is concern about the husbandry of the animals. Both the RSPCA and DEFRA have been informed and the live sheep were removed recently. This has caused public concern and the Parish Council will write to the authorities requesting the outcome of their enquiries.

Cllr. Mrs. E. Cookson reported the party will go ahead this year, restrictions permitting, on 14th December with entertainer Eric Lee.

Pilling in Bloom

Pilling was judged last month for North West in Bloom; results to be announced in October. Pilling is through to the semi-finals of the Best Kept Village Competition and should know this week if through to the finals. Councillors all commented positively to the look of the village and the many floral displays. The Parish Lengthsman raised purchasing a power washer last month and has tested a suitable model, Councillors agreed to its purchase.

Report of the representative on Pilling Village Hall

Cllr. P. McWhirter reported on the new organisations and hirers of the Village Hall, the committee room is being booked for local business meetings. The next weekend event is 'A Trip down Memory Lane'. Friday social evenings will start shortly.

Pilling Flood Action Group/Wyre Flood Forum/ Water Meeting Wyre Flood Forum

The following noted in the minutes and Carl Green, Wyre Council asked for details. As part of the Innovation Bid, Lancashire has been awarded £7.4m to look at different ways of using buffer strips (such as salt marshes and sand dunes) to provide coast protection and allow time for the land to adapt to coastal changes. The scheme comprises fourteen projects of which three are within Wyre (use of dredged material to improve the saltmarsh and protect the seawall at Fleetwood Docks; improvements to the saltmarsh at Arm Hill, Preesall; and developing an inter-tidal lagoon at Pilling to improve the local drainage systems.) Item to be forward to Wyre Councillor Holden to investigate in Wyre.

The Environment Agency has failed to clean out their dyke running under Fanny Bridge to the Broadfleet, which will be raised locally.

Wyre Area Lancashire Association of Local Councils

Planning Enforcement can be viewed on Wyre's site, although very few, when Wyre Council has admitted there are over 170 outstanding. Several enforcements were raised, and these will be taken to planning with answers to follow!!

Wyre Council has received further Covid grants totalling £50m, including local discretionary grants, to be given by March 2022.

DEFRA is to consult on the future of waste, packaging used by manufacturers and a deposit scheme!!

Meeting with Cat Smith MP

Councillors met with the MP concerned about the continuing disruption with the sewer on Damside. She has written to Cllr. A. Whiteside reiterating work by United Utilities will be a multi-million project and funding must be sought with work starting next Spring.
