#### 4219. DECLARATION OF INTERESTS

Councillors were asked to disclose pecuniary or non pecuniary interests in matters to be discussed at this meeting.

All councillors disclosed an interest in the Pilling Memorial Hall planning application as holding trustees of the hall and a dispensation was applied.

#### **Police Report**

Councillors noted the figures for the past month, but these had not background reports to support them. Councillors expressed the policing of the parish as a partnership with the Police and are disappointed in the deterioration in the quality of the service in the last 18 months. It has gone from a personal Police presence at meetings to a bland set of figures. It was raised that the Police are now working through social media for information collection and dissemination. The Parish Council will contact the Police looking for better communication.

The meeting was resumed.

#### Senior Citizen's Christmas Party

It was raised that as the Pilling Charities Dance Group has now closed the party will receive less in donations.

#### Report on progress of the Pilling Defibrillator Appeal

Councillors were presented with an update on donations towards the provision of defibrillators in Pilling. Cllr. Moorat will be meeting the North West Ambulance Service to settle on prices and order the defibrillators.

#### Report on the Eagland Hill Wind Turbine Fund

The initial meeting was held on 30<sup>th</sup> March attended by Cllr. Moorat from Pilling Parish Council plus representatives from around the turbines. The grant of £16,000 per year will be managed by Grantscape and the working group resolved that it is split to supply two application periods per year, the first round date will be in June. The fund will be officially launched on the web site soon, with local publicity to follow. The funding area is within 3Kms of the turbines and includes Eagland Hill, but not Pilling; as such the Parish Council will be applying for a further defibrillator for the Eagland Hill area.

There was appreciation of Cllr. Moorat for initiating and running with this worth while project for the benefit of Pilling residents.

## 4226. QUESTIONS FOR COUNCILLORS

#### Pilling News

The withdrawal of the Pilling News and its personal delivery to households in the Parish was raised. This had served to inform residents of what was happening with the Parish Council and could be used to disseminate information of the new hall to keep everyone up to speed and hopefully get new recruits. A newssheet is to be produced to be left in businesses, public buildings and shops. The Pilling 20 20 project is to produce a new web site and this can be linked into the new Pilling Parish site.

#### Dogs on the Sea Wall

It has been raised to Councillors that the number of dogs on the sea wall off the lead is increasing and some of these dogs are worrying the ewes in fields resulting in a greater number of still births seen by the farmers. The Parish Council will remind the Environment Agency of their responsibility to provide notices informing walkers of their duties when on the sea wall.

It was noted that some of this Parish Council would not be standing for the new Council and they were wished the best for the future.

There being no further business the Chairman closed the meeting at 9.30pm.
