Pilling 20 20

Plans have been just been submitted to Wyre Council by MCI Developments for:

Demolition of the existing Pilling Memorial Hall and erection of 25 affordable homes, including the construction of a new access road off Taylors Lane AND

Outline Planning application for the erection of a new Pilling Memorial Hall and associated car parking including formation of a new pedestrian and vehicular access from Taylor Lane, associated landscape planting, the creation of recreational open space, children's equipped play area, tennis court/external multi use games area (MUGA) one full size pitch and one 3/4 size football pitch.

Once the new field is secured then grant funding will begin in earnest and YOUR help, as a Pilling resident will be vital to seeing our new hall and sporting facilities through to its completion. To join Pilling 20 20 contact John Savage, secretary of Pilling Memorial Hall for further information.

Taylors Lane Speed Limit

The Parish Council is aware that the speed limit on Taylors Lane has been a confusing problem for many years, but with the introduction of the following legislation the situation is to be resolved.

NOTICE OF PROPOSAL LANCASHIRE COUNTY COUNCIL ROAD TRAFFIC REGULATION ACT 1984 (TAYLORS LANE, PILLING, WYRE BOROUGH) (RESTRICTED ROAD AND 30MPH SPEED LIMIT) ORDER 201*

County Council

NOTICE IS HEREBY GIVEN that Lancashire County Council propose to make the above Traffic Regulation Order under Sections 82, 83 and 84 of the **Road Traffic Regulation Act 1984,** as amended, the effect of which will be to:

 Introduce a 30mph speed limit on Taylors Lane, Pilling, from the centre line of School Lane, for a distance of 230 metres in a south-easterly direction.
Introduce restricted road status (30mph speed limit will apply) on Taylors Lane, Pilling, from a point 230 metres south-east of the centre line of School Lane to a point 162 metres north-west of the centre line of Lancaster Road.



Statement of Reasons

Lancashire County Council are proposing to alter these speed limits in accordance with national guidelines to reduce potential accidents and increase journey safety.

The Parish Council wishes to reiterate that Mill Bridge is ALSO 30 MPH

Pilling Remembers World War I


On 4th August, 1914 World War 1 started
