4206. APOLOGIES FOR ABSENCE

Apologies were received for this meeting from Cllr. E. Moorat and Cllr. J. Savage. In the absence of the Chairman Cllr. G. Curwen took the Chair for this meeting.

4207. DECLARATION OF INTERESTS

Councillors were asked to disclose pecuniary or non pecuniary interests in matters to be discussed at this meeting.

4208. MINUTES OF THE LAST MEETING

Resolved; The minutes of the last meeting, held on 11th February, 2015, having been circulated, were agreed and signed by the Chairman as a true record.

4209. PUBLIC PARTICIPATION

The meeting was adjourned to allow the residents present to speak.

Police Report

Crimes reported last month include a farm house and office broken into on Skitham Lane and cash stolen, both the Reading Rooms and St. Johns Church on School Lane were broken into and items stolen. An antique shotgun and items of jewellery were stolen during a burglary at premises on Head Dyke Lane, through a sash window and forced open a safe and gun safe. Scrap copper wiring was stolen from outside a business premises on Taylors Lane.

There are no anti-social behaviour patterns but a report of issues with a neighbour on Longwood Lane, after bailiffs had been to secure the property and a farmer rang in to report the occupants of a car acting suspiciously in the England Hill area, possibly lamping unlawfully.

The meeting was resumed.

4210. NEW WEB SITE FOR PILLING PARISH

Councillors considered updating the website by using a local professional firm; who offer an up to date product which gives a fully responsive display on all forms of communication devices. Whilst the present website is 'fine' perhaps it is time to update, more especially as the clerk has been unable to publish the site for some time due to

the server being down again!! There is a charge of £500 initial set up fee and monthly running fees of £20.

Resolved: Whilst the Councillors agreed with an updated site, funding will be sought to assist with the set up costs initially.

4211. RISK ASSESSMENTS

Councillors reviewed the Risk Assessment and Risk Management Plan.

Resolved: Pilling Parish Councillors accepted the Risk Assessment and Risk Management Plan as presented.

4212. PROPOSED CHANGES TO VILLAGE SPEED LIMITS

Lancashire County Council is considering lowering the speed limit on Lancaster Road, through the built up area from Head Dyke Road through to the end of Fishers Row. Councillors made comment on the proposal.

Resolved: Pilling Parish Council fully supports the lowering of the speed limit on Lancaster Road to 30MPH.

Report on progress of the Defibrillator Appeal

Cllr. E. Moorat presented a written report on progress with the donations and promises to date. This alters weekly as residents and organisations learn of the appeal.

Report of the representative on Pilling 20 20

A meeting was held on 19th February with the developers, MCI, when an agreement to retain the hall as long as possible was dashed as the Government grant criteria specified demolition on purchase of site and Regenda was to sign up by 31st March, 2015. On a positive note the business plan is to be used to access where the committee is and the direction of progress needed, Mike O’Loughlin a Pilling resident is greatly assisting in the compilation of the updated business plan. This has been written in line with the Big Lottery criteria and is more focused, as serious deficiencies were highlighted. The plan does not need submission at this stage. Initially the group must ring the Big Lottery, outlining the proposal and hopefully succeeding to the second stage. This fund could yield up to £500,000.

Evidential proof is being gathered and information from census’. The completed gateway form will assist with the appointments of architects. The project meets many needs in Pilling.

1. Working with Wyre Council through support from Garry Payne as provision of a Pilling Hub.
2. Addressing the housing needs in the Parish.
3. Tackling rural isolation/geographical position for the elderly and younger members of the community.
4. Transport through Pilling to urban conurbations.

The group is identifying smaller funding bodies to provide facilities as part of a larger scheme with the Big Lottery.

An open presentation showing the last 103 years of the Pilling Memorial Hall is to be held 29th March. The imminent closure of the Memorial Hall has
