4086. ELECTION OF CHAIRMAN

4091. PUBLIC PARTICIPATION

The meeting was adjourned to allow residents to speak.

Police Report sent by Sergeant Freaney

The Chairman read the report crimes for the last month saw the window of a vehicle damaged whilst parked, unattended on School lane, a Catterall man charged with assault, after an incident on Garstang Road, a quad bike stolen from a barn on Pilling Lane and fuel siphoned from vehicles parked on the car park of a business premises on Lancaster Road.



Anti-social behaviour incidents included a cat owner became aggressive to the person who had hit the animal insisting that the vets bills were paid, a suspicious car left on School Lane for several days, but as it was taxed and insured and not committing any offences there was nothing that could be done and inappropriate nuisance calls to a resident at a caravan park on Head Dyke Lane.

Planning Application off Lancaster Road

A resident of Garstang Road was very concerned at the way Wyre Council deals with the planning amendments, in particular the affordable housing off Lancaster Road, which he commented on. The application went to Planning Committee for decision, but the report produced for the councillors shortened the resident's comments to the point of lacking any substance. The original application was for 12 houses and when this was reduced to 11 it appears the statutory consultees were not informed and therefore no further comments are on the webpage to the amended application.

He raised Wyre's website page for this planning application; saying it is confusing and there is no way to differentiate between original, superseded and revised plans. The Councillors were disappointed as meetings with Wyre Council have brought forward the need for consultation and Wyre asking to work with the Parishes.

Pilling Jubilee Silver Band

Mr. Jim Redman, leader of Pilling Jubilee Silver Band spoke to the Councillors about the projected work for the coming year. The band will be 80 years old and hope to celebrate the occasion with the resurfacing of Field House Lane. Residents living on the lane have frontage rights to the lane and the responsibility for its maintenance.

The band came 5th in the regional finals in Cheltenham last year and this year will be holding a number of events to raise funds, including an Anniversary Raffle on 1st August, An evening concert at Pilling Church on 31st August and a 'Brass in Concert' on 4th October.

The meeting was resumed.
